### FACTUAL BACKGROUND

Ježisti d-dominju [www.starinteriors.eu](http://www.starinteriors.eu) li għadu aċċessibbli u li jidher li jintuża biex jippromwovi is-servizzi ta' kumpanija li tagħmel xogħol ta' "turnkey contracting", "interior design" u "final finishing" f-Malta. Mill-evidenza ippreżentata jidher li tilwima bejn l-azzjonisti f'din il-kumpanija giet riżolta permezz ta' xiri tal-ishma tar-Respondent Dragan Miculovic fl-istess kumpanija mill-Lmentatur Pavle Milovanovic.

### A. COMPLAINANT

L-ilmentatur iddiċċjara u ppreżenta evidenza dokumentarja li xtara l-ishma tal-kumpanija Star Interiors Limited, kumpanija irregjistrata Malta bin-numru C-86406 u dan permezz ta' kuntratt magħmul fil-preżenza tal-Avukat Gianfranco Gauci, Birkirkara, Malta, nhar it-tmintax ta' Mejju 2023 bejn l-ilmentatur Pavle Milovanovic u r-Respondent Dragan Miculovic. Gie ippreżentat ukoll dokument separat li jidher l-istess data tat-tmintax ta' Mejju 2023 izda li mhux iffirmat u li ma jidherx li jagħmel parti formali mill-istess kuntratt, iżda li għandu sura ta' rċevuta mogħtija mill-Lmentatur Pavle Milovanovic lir-Respondent Dragan Miculovic u li tinkludi espliċitament id-dominju [www.starinteriors.eu](http://www.starinteriors.eu). L-ilmentatur qiegħed jghid li l-assi digitali kienu inklużi meta xtara l-ishma fil-kumpanija Star Interiors Limited.
